Cottonwood Dr. Repair Project -

Cottonwood Dr. is scheduled for repair for approx. the 1st or 2nd week of September. The sections to be repaired are from the Weber River Bridge and going around the curve.

I-84 Overcrossing -

The I-84 Overcrossing is scheduled for repair immediately following the completion of the Cottonwood Dr. Repair Project. Construction is scheduled to begin approx. the 2nd or 3rd week of September.

Safe Sidewalks to School Grant Project -

Installation of new sidewalk improvements along South Weber Drive from approx. 1550 East to 1700 East commenced on August 14th and is scheduled for completion September 4th.

Gravel Pit Dust Committee Update:

In an effort to mitigate the dust from the gravel pits, Staker Parsons Companies reports that sprinklers are in place and operating each morning during wind events along the west rim. The damaged wind fences have been removed and new ones are being built; some of which have already arrived and are in the process of being installed along the west end. The original fences are still in place along South Weber Drive. Also, a water truck continues to spray down the areas where mining occurs; beginning at 3 am and continuing throughout the course of the day. Magnesium Chloride treatment has also been applied to traffic areas since early July.

The committee has discussed and proposed the planting of Elm trees along the west side. No action has taken place yet as the planting of additional trees will require some reclamation along the west end of the property prior to planting. Staker Parsons Companies reports that this area is still in use and the planting of trees will be an action item upon completion of the reclamation. Slope and seeding will take place when mining areas are complete. Additionally, many areas throughout the facility are reclaimed and growing vegetation. Staker Parsons Companies reports that no new action since the last committee meeting held on July 19th has taken place regarding reclaimed and growing vegetation.

Staker Parsons Co. has formed an internal committee to mitigate the dust. This committee which will include the involvement of the City's code enforcement officer, is scheduled to meet twice a month. The next Gravel Pit Committee meeting will be held on Wednesday, September 27th at 5:30 pm at the City offices. All that wish to attend are invited.

CODE ENFORCEMENT

In last month's newsletter, the possibility of having a dumpster program throughout the city was announced, and surprisingly, over 25 requests for a dumpster to be placed near resident properties were submitted. It was difficult to choose which areas to place them, but it has been decided that the first dumpster will be placed near 7531 S. 1550 E. It will be placed on September 1st and will remain in that location until September 11th, unless the Code Enforcement Officer deems that it be removed earlier. The second location will be near 7700 S. 1875 E. It will be at this location from September 11th to September 18th. This is a trial program only, and based on its success or failure will determine if the city will continue to provide the service. Please take this opportunity to remove any nuisance items on your property, encourage your neighbors to do so as well, and offer your assistance to help South Weber City stay the best place to live. Please do not dump tires or any hazardous chemicals into the dumpsters. Any violation will be cause for removal of the dumpster program for all South Weber City residents. Greetings South Weber Residents,

We had a successful month in August with The Tour of Utah Race and South Weber City Country Fair Days. Both events went very smoothly with credit given to the hard-working team of the South Weber City Administration, Public Works, Fire Department, and Volunteers. South Weber City even made international television airtime during the Tour of Utah as riders from around the world pedaled through our beautiful city.

This month, and with the start of hunting season approaching us, I would like to remind everyone about firearms safety. There are four simple safety rules to follow regarding firearm safety, and it is important to note that every firearm accident that I have responded to in my 20 years of public service, at least one of these rules were violated. Regardless if you are in a firearm related profession, a hunter or hobbyist, or a soldier up to and including our special operations soldiers, these firearms safety rules must be practiced extensively. The four firearms safety rules are as follows:

1. Treat every gun as if it were loaded.
2. Always keep the muzzle pointed in a safe direction.
3. Keep your finger off the trigger, until you are ready to fire.
4. Be sure of your target and what's beyond.

Please help us prevent a tragedy by observing these safety rules. Also, talk with your children regarding firearms safety and what to do if they come across an unsecured firearm (my suggestion is not to touch it and tell an adult that it needs to be put away), and last, never store firearms and ammunition together.

[Air Force Offers Air Sampling in South Weber City](#)

Hill Air Force Base will soon begin contacting homes and businesses near areas of groundwater contamination coming from the base, to notify them that potentially harmful chemical vapors from the groundwater could be entering their homes or workplaces. Those in the affected areas will receive a certified letter from the Air Force explaining the issue and providing instructions on how to have the air inside the home or business tested. Tests will begin in October and go through March of 2018. If vapors are found above established action levels, the Air Force will take steps to prevent those vapors from entering the home or building. The drinking water has not been affected by the contamination.

The Air Force has been testing the air inside homes around Hill since 2003. As always, the testing is free, as are any future mitigation efforts. If you do not receive a certified letter, your home or business is not within an area of concern.
