

Agenda Item: Award Touchless Fixtures Project

Background: Bids were solicited from 5 referred companies to install touchless fixtures throughout the City facilities and parks. Four of those companies expressed interest in the project initially; 2 toured the facilities/parks and indicated they would submit a bid while the other 2 removed themselves from consideration citing a currently full project schedule. Ultimately, only KR Plumbing submitted a bid, totaling \$47,696.

When only one bid is received, the City procurement policy allows for the City to re-solicit for additional bids or proceed with a procurement award using the single bid received. The bid is under the \$50,000 CARES allocation for this project, is from a reputable company, and must be completed by the end of the year according to the CARES funding timeline requirements. Therefore, staff feels comfortable awarding using the single bid received and recommends awarding the project to KR Plumbing.

RESOLUTION 2020-48 A RESOLUTION OF THE SOUTH WEBER CITY COUNCIL AWARDING TOUCHLESS FIXTURES PROJECT CONTRACT

WHEREAS, South Weber City received funds from the Coronavirus, Aid, Relief, and Economic Security (CARES) Act for use toward fighting the Coronavirus; and

WHEREAS, City Council decided installing touchless fixtures at City Parks and in City Buildings would decrease the spread of the virus; and

WHEREAS, bids were requested from five companies with the understanding that the work must be completed by the end of the year; and

WHEREAS, the expedited installment schedule limited those who responded to two companies with only KR Plumbing submitting an actual bid in the amount of \$47,696; and

WHEREAS, there is not time to solicit additional bids and this company is known to be reputable;

NOW THEREFORE BE IT RESOLVED by the Council of South Weber City, Davis County, State of Utah, as follows:

Section 1. Award: The Touchless Fixtures Project Contract is hereby awarded to KR Plumbing in the amount of \$47.696.

Section 2: **Repealer Clause**: All ordinances or resolutions or parts thereof, which are in conflict herewith, are hereby repealed.
