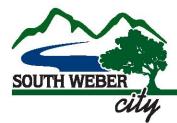

Mayor Sjoblom called the meeting to order and welcomed those in attend.

**Merv Taylor, 8062 S. 2300 E.,** conveyed he has been a resident for over 30 years and was speaking on behalf of the silent majority group. He thanked the City Council, Mayor, and city staff for their service on behalf of South Weber City. He advised they not listen to the vocal minority group who want to keep this city from moving forward and keep individuals from moving into it. He proclaimed this is a great city to live in and he did not think the city should be limited. He supported building the road to Layton.

**Paul Sturm, 2527 Deer Run Drive,** expressed his appreciation to the Mayor, City Council, and city staff for all of the work involved in preparing the budget and reviewing the other information for tonight's meeting. He also thanked City Engineer Brandon Jones and his staff at Jones & Associates for preparing the long-awaited Storm Drain Capital Facilities Plan (CFP) & Impact Fee Facilities Plan (IFFP) that were last completed in 1999. The attention to detail shown in this current plan demonstrated a superior work effort. He proclaimed the street maintenance project clearly informed residents of pending projects to improve city streets. He questioned Chapter 7, Section 5 of the Consolidated Fee Schedule. He noted Parks and Trails, Public Safety Fire Station, and Recreation Building all show an impact fee per dwelling unit whereas, Sewer has no distinction shown for the number of dwelling units. He inquired if this was an oversight.

**Michael Grant, 2622 Deer Run Drive,** vocalized if most of the revenue from Staker Parsons gravel pit goes to Roy City and that from Geneva gravel pit goes to Draper, how does South Weber City benefit?

Councilman Winsor explained sewer and water fees are based on water meter size into the house not per dwelling.

Councilwoman Petty related Staker Parson Company donates to South Weber City's recreation department. Last year's donation was close to \$90,000.

City Manager David Larson clarified the city receives money from Staker Parson Company in a number of different ways. The city receives sales tax from there point of sale. Approximately, 10% of sales tax the city receives come from Staker Parson. There is also a donation that is specifically designated for the recreation program based upon the development agreement and the amount of material extracted.

### 5. Public Hearing for Tentative Budget 2021-22

Mayor Sjoblom explained the City Council approved the tentative budget 2021-22 on 11 June 2022. Mayor asked if there was any public comment. There was none.

Councilman Winsor moved to close the public hearing for Tentative Budget 2021-2022. Councilwoman Alberts seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

Councilman Winsor moved to open the public hearing for the Storm Drain Capital Facilities and Impact Fee Facilities Plans. Councilwoman Petty seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

6. Public Hearing for Storm Drain Capital Facilities Plan and Impact Fee Facilities Plan

### City Engineer Brandon Jones memo of 1 June 2021 is as follows:

### STORM DRAIN CAPITAL FACILITIES PLAN

A Capital Facilities Plan (CFP) is a planning document which summarizes the findings of system analyses and provides recommendations for expansion as development takes place. It identifies and provides cost estimates for existing problems and deficiencies within the system. Additionally, the impact of growth is considered in order to recommend effective and efficient improvement/expansion within the system to meet future needs. This analysis is performed looking into the future through built-out.

<u>Need for new CFP</u>. The most recent CFP completed for the storm drain system in South Weber was in 1999 by Hansen, Allen & Luce (HAL). Jones & Associates, as the appointed City Engineer, was commissioned to provide a new CFP for the storm drain system. Due to the length of time between the HAL study and this study, as well as the many changes that have occurred in the city due to development, there is not much from the HAL report that is relevant to current conditions. Therefore, the J&A report provides a new and independent analysis of the city's system and does not use any of the data or information from the HAL report. The costs identified in the report are needed as the basis for updating the storm drain impact fee (future development) as well as the storm drain utility fee (existing residents).

<u>Study Area</u>. The Study Area includes the entire city boundaries as well as areas shown for annexation. The study area for a storm drain study must also include all areas where drainage flows into the city. Therefore, the mountain drainage to the east and the hillside drainage to the south are also included. The study area, as well as the existing storm drain system, is shown in Exhibit 2.1 in the report.

Existing System. A computer model was created to analyze the current conditions of the storm drain system. This model identified existing deficiencies in the current system. Fortunately, there were only a few areas identified where flooding may occur, and it is only likely to occur with high-intensity storm events. We feel that the risk of damage to property from these events is moderate. Therefore, there is no immediate threat, but these projects should be addressed as soon as funding is available. These areas are not new. Public Works personnel have seen flooding in these areas in the past.

<u>Future System</u>. The computer model then added in the future conditions through built-out. The basis for analysis of future conditions is the current General Plan (adopted on November 10, 2020). The growth is analyzed based on the increase of hard surfacing. Using the Projected Land Use Map, areas were identified where development is likely to occur. The model identified the needs of the future system. The difference between the existing system needs and the future system needs is what is attributable to future growth.

<u>ERU's.</u> To evaluate various types of land use, a basic unit of measure is needed. This is simplified to what is called an Equivalent Residential Unit (ERU). As storm water runoff is mainly generated by hard surfacing, the ERU is calculated based on how much directly connected hard surfacing a typical single-family residential home contains. This was calculated to be 3,365 sf. The current and projected ERU's are shown in Table 3.4 in the report. A map of the anticipated future ERU's is contained in the report as Exhibit 3.1.

<u>Projects.</u> Based on the existing deficiencies and future needs, concept-level projects were identified to address these needs. 26 projects were identified. Table 5.1 gives a description of each project. A cost estimate for each project is contained in Appendix C. A summary of the project costs is shown in Table 5.2. The projects are broken down into three categories: Existing Deficiency, Impact Fee Eligible, and Developer Cost. In the report, the Existing Deficiency costs are calculated to be approximately \$6.0 million. These costs need to be covered by funding from the existing residents (e.g., storm drain utility fee, capital projects, etc.). The Impact Fee Eligible costs are calculated to be approximately \$1.87 million. These costs are covered by future development through the impact fee. The Developer Cost is the portion of the project that is attributable to infrastructure required only for that particular development. This is needed as a base line to determine the upsized portion that is impact fee eligible. This portion is covered by the developer.

<u>Public Works Facility</u>. Projects 1- 25 consist of piping or detention/retention facilities. Project #26 is for the Public Works Site and Facility. The storm drain portion of the facility is identified as 20% of the total cost. Of that cost, 65% is attributable to existing needs and 35% to future needs. For a more detailed breakdown, see the cost estimate contained in Appendix C.

<u>System Replacement.</u> An evaluation was done on the need for replacement of existing infrastructure based on it reaching the end of its design life. No projects were needed.

<u>Needs Assessment and Project Prioritization</u>. A needs assessment was performed of each project based on Criticality, Condition, and when the project is anticipated to be needed. This assessment can be found in Appendix E of the report. Each project was scored and then reordered according to their evaluation score with the highest scoring projects at the top of the table, thus showing the prioritization and order in which projects should be accomplished.

**STORM DRAIN IMPACT FEE FACILITIES PLAN** Utah state law requires that an Impact Fee Facilities Plan (IFFP) be prepared before an impact fee can be implemented. The IFFP is a subset of the data contained in the CFP. State law requires that the IFFP only contains the cost for projects expected to take place within 6-10 years and must not raise the level of existing service. Section 6.0 of the report covers the IFFP. Table 6.2 identifies the projects anticipated to be needed in the next 6-10 years. Due to the rapid rate of development and the areas where these projects are needed, all the impact fee eligible projects identified in the CFP are included in the IFFP, totaling approximately \$1.87 million.

<u>Adoption.</u> The IFFP identifies the impact fee eligible costs but does not calculate the impact fee. The IFFP must be adopted before this calculation can be done. This is done in a separate report, which is called the Impact Fee Analysis (IFA). The city has contracted with Zions Public Finance Inc. (ZPFI) to perform this analysis.

Councilwoman Alberts asked Brandon about alleged problems with the Silverleaf retention basin. Brandon replied the model shows it is working as it was designed and is sufficient for what it needs to provide. The maintenance has an impact on how basins function and he did not think anything needed to be added to the CFP.

Mayor Sjoblom asked if there was any public comment. There was none.

Councilman Winsor moved to close the public hearing for the Storm Drain Capital Facilities and Impact Fee Facilities Plans. Councilwoman Petty seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

7. Ordinance 2021-08: Storm Drain Capital Facilities Plan and Impact Fee Facilities Plan Jones and Associates was tasked with creating a Capital Facilities Plan for storm drain to summarize system analyses and provide recommendations for expansion as development occurs. South Weber's storm drain system was analyzed through software modeling for transmission capacity, storage capacity, and overall system effectiveness; and projects were identified in the Capital Facilities Plan (CFP) to correct existing deficiencies and identify needs for system improvements necessary for future development. Utah state law (Title 11-36a) requires that an Impact Fee Facilities Plan (IFFP) be prepared before an impact fee can be enacted. Projects were identified in the IFFP to provide system improvements necessary for anticipated development in the next six-to-ten-year planning window. The estimated cost of \$1,866,080 is impact fee eligible.

Councilman Winsor expressed gratitude to the city staff and the outstanding job on the CFP and IFFP. He pronounced some of the pipe identified as deficient are laying in a flat section. City Manager David Larson announced the next step will be an Impact Fee Analysis and impact fee enactment as well as a rate study for the storm drain fund.

Councilman Winsor moved to approve Ordinance 2021-08: Storm Drain Capital Facilities Plan and Impact Fee Facilities Plan. Councilman Halverson seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

### 8. Resolution 21-32: 2021 Street Maintenance Project

Mayor Sjoblom announced on June 3, 2021 at 2:00 pm. bids were opened for the 2021 Street Maintenance Projects. Nine bids were received. The results of the bidding were shown on the bid tabulation provided by Jones & Associates.

This project was bid out with six separate sections. Section A (Mill & Overlay), Section B (Chip & Seal), Section C (Trail Seal Coat), Section D (Concrete Work), Section E (Fire Station

Concrete Driveway), and Section F (Crack Fill). The overlays are on Heather Cove, 475 East, and View Drive. The chip & seal is on Old Fort Road and a portion of Canyon Drive. The trail seat coat is on the Old Maple, Freedom Landing, and Cottonwood Cove trails. the concrete work is located all over the city and involves replacing a lot of sidewalks and ADA ramps. The fire station concrete driveway would install a new driveway from the road and along the north side of the fire station to allow the fire trucks to pull through the bays from the back rather than back up from the front to park. The crack fill will be on various roads showing the highest need. All these projects are in the current proposed budget for FY2022. For Sections A, B, and C several alternate bid items were included to determine pricing for additional options on asphalt mix designs and different types of seal coats.

Multiple bids were received on all sections except Sections D and E which are the concrete sections. There is a current concrete shortage and high demand for concrete contractors which could be the cause. City Engineer Brandon Jones will research other options but may end up just re-bidding the concrete work next year. All bids were reviewed, and Jones & Associates recommended awarding four separate contracts to the following:

**Councilwoman Petty moved to approve Resolution 21-32: 2021 Street Maintenance Project as follows:** 

Section A award bid to Kilgore Contracting for \$388,046.00 for mill and overlay Section B award bid to Staker Parson Companies for \$136,385.50 for chip and seal Section C award bid to Advanced Paving & Construction for \$6,453.50 for trail seal coat Section F award bid to CKC Operations, LLC for \$27,500.50 for crack fill

Councilman Halverson seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

### 9. Resolution 21-33: Interlocal Agreement for Paramedic Services Transfer

Mayor Sjoblom stated on March 9, 2021, South Weber City Council passed a resolution approving the transfer of paramedic services from Davis County to South Weber City. Since that time Davis County has agreed to pay for paramedic services during the transition period, so the city does not pay until the transfer which is scheduled to occur no later than December 31, 2022. (See section 7b.)

The agreement makes one other change amending Section 3. The deadline for each city or district to provide a commitment letter to the county stating how the entity will provide paramedic services switched from June 1, 2021, to August 30, 2021to accommodate the various truth in taxation hearings required.

Councilman Winsor questioned Section 7 which read as follows:

### 7. Funding.

a. Each Party shall be responsible to budget from its own General Fund or obtain funding from other sources for any additional funding for the paramedic units allocated to it under this agreement or for any additional paramedic units or services which that Party determines to provide. It is anticipated that services from a jurisdictional authority to unincorporated areas of the County will be compensated through separate arrangements between the County and the servicing jurisdictional authority.

Councilman Winsor specified South Weber City has some unincorporated areas on the east side of Highway 89. He asked if it is anticipated that they fall within the city's service area and would the city need a separate arrangement. City Manager David Larson replied that South Weber City will need to work with Davis County concerning the development of a separate agreement for how that would be handled. Councilman Winsor conveyed in the past Mayor Sjoblom signed similar agreements.

Councilman Winsor moved to approve Resolution 21-33: Interlocal Agreement for Paramedic Services Transfer with Mayor Sjoblom signing the agreement. Councilman Soderquist seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

### 10. Resolution 21-34: Interlocal Agreement for Dispatch Services

Mayor Sjoblom explained South Weber City contracts with the Davis County Sheriff's Office (DCSO) for Fire/EMS dispatch services. The contract renews annually with an updated cost based on a five-year average of calls and a per call amount. The proposed price per call is \$32.45 and the call volume average is 304 for a total amount is \$9,864.80. For comparison, last year's contract had a total price of \$8,633.74 with a per call price of \$31.51 and five-year call volume average of 274.

Councilman Soderquist moved to approve Resolution 21-34: Interlocal Agreement for Dispatch Services. Councilman Winsor seconded the motion. Mayor Sjoblom called for the

vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

### **DISCUSSION ITEMS:**

### **11. Consolidated Fee Schedule**

The Consolidated Fee Schedule (CFS) was last adopted on June 16, 2020. The Tentative Budget for 2021-22 includes a change to the Sewer Utility Fee and the Sanitation Fee. Additional grammar and clarification changes were also made by staff. The CFS was before the City Council to discuss those changes with the adoption to follow on the June 22, 2021.

Councilman Winsor asked if burning CDs should still be an option. The response was that the city still has capability to do so. He recommended adding internal accessory dwelling unit to Chapter 5. David revealed the city has until 1 October 2021 to put that in place so it can be amended later. Councilman Winsor noticed Chapter 7 item #8 had two definitions for the \* and questioned which definition applied. David responded both and Mark suggested combining them into one. Councilman Winsor recommended adding fees for basketball and pickleball in Chapter 14 as there is a fee for volleyball. Councilwoman Petty verified the Parks and Recreation Committee will be conducting research for pricing. Councilman Winsor noted a formatting issue in Chapter 16 item 2a and suggested changing 2.3 to 2.30.

Councilman Soderquist appreciated the summary of the amendments submitted by Mark. He recognized there are business license fees which are not clear as to whether they are one-time or annual fees. Mark was directed to review them. Councilman Soderquist suggested amending the mobile business license to a fee per year. He requested the Parks and Recreation Committee review if citizens should be charged a fee to use the volleyball, pickleball, and basketball courts.

Mr. McRae thanked the staff, City Council, and Mayor for reviewing the Consolidated Fee Schedule.

### 12. American Rescue Plan (ARP) Act Update

The American Rescue Plan (ARP) Act of 2021 was passed on March 10, 2021. On May 10, 2021, the Treasury Department issued its guidelines on the act. City staff gave a presentation on what is known so far about the funding the city expects to receive, the timeline for receiving and spending these funds, and eligible uses of the funds. The final guidance and distribution of the funds to South Weber City will come from the state.

Mark reviewed highlights stating South Weber City is a non-entitlement city so the state will distribute funds to the city. The estimated amount for South Weber is \$832,000; however, the State of Utah will make the final decision as to how much South Weber City will receive. It is anticipated the first payment will be in July and then the second payment will be the following year. Funds can be used for the following:

- 1. Premium pay for those who worked during COVID
- 2. Water, Sewer, Storm Water, or Broadband Infrastructure
- 3. Possibly Cyber Security to the water, sewer, and storm water infrastructure

The city has until 1 December 2024 to allocate the funds.

Councilman Winsor asked if a Public Works Building would qualify as a legitimate project. Mark replied that it does not but as it relates to the infrastructure, the city can petition the Treasury Department to have it declared eligible.

### 13. Recreation, Arts, and Parks (RAP) Tax

Mayor Sjoblom explained if approved by the residents, a municipality may increase the sales and use tax by 0.1% to specifically fund parks, cultural, and recreation programs commonly referred to as a RAP, RAMP, or ZAP tax. Under UCA 59-12-1402, this potential increase may be placed on the ballot as an opinion question. A municipality may not impose this tax if the county in which it is located already imposes the tax. If implemented, revenues generated from a RAP tax may be used for capital improvements and operations of publicly owned/operated amenities such as (but not limited to) parks, playing fields/courts, trails/bike paths, etc.

The Council must decide whether to put this issue on the ballot for this November because notification must be to the Lieutenant Governor's office 75 days prior to the election with an additional 60 days prior to that for the county to review the intent and provide a response. If the Council decides to pose the question to the community, a voter information pamphlet must be prepared that would include the exact ballot language, arguments for and against the proposition, and location and date of the election.

A 0.1% sales tax equals 1 penny for every \$10 spent. City staff estimated a RAP tax would generate approximately \$60,000 per year based on current sales tax projections. If citizens approve the tax, it would be in effect for 10 years. A reauthorization vote would then be required to see if the community would like to continue to utilize the tax.

Councilwoman Alberts asked who composes the information for the pamphlet. David replied there is a specific process as to who writes it. Councilman Soderquist submitted the public needs to understand the City Council is not promoting this tax, just presenting the information.

Councilman Halverson and Councilwoman Alberts were in favor of a RAP Tax. David verified the city website can include information, but the city would only be in charge of putting together the voter information pamphlet. Councilwoman Petty and Councilman Winsor agreed to move forward.

### 14. Property Tax Certified Tax Rate

City Manager David Larson expressed the adopted Tentative Budget for fiscal year 2021-2022 includes a proposed property tax rate increase. A Truth-in-Taxation hearing is scheduled for August 17 at 6:00 pm at City Hall on the proposed 2021 property tax rate for South Weber City. Following this public hearing and prior to the end of August, the City Council must formally adopt a certified tax rate for 2021. On June 22, 2021, the City Council will adopt a proposed tax rate which will then be published in multiple mediums to inform the citizens of the public hearing and the proposed tax rate change. This discussion was to direct staff on what rate to prepare for the June 22 meeting.

The tax rate increase relates to Davis County transferring paramedic service over to South Weber Fire/EMS. Davis County will no longer be assessing the Paramedic tax levy beginning this year. The service and the tax rate to fund our own paramedic operations will be picked up by South Weber City according to an inter-local agreement with Davis County previously approved by both parties. The property tax rate for South Weber City for 2020 was .001403 and produced

\$754,000 in revenue for the City. The paramedic tax rate for 2020 was .000119 and produced \$63,953 in revenue for Davis County from property in South Weber City.

Councilwoman Petty moved to approve Resolution 21-35: Budget 2020-2021 Amendment #6. Councilman Soderquist seconded the motion. Mayor Sjoblom called for the vote.

# Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

### 7. Resolution 21-36: Consolidated Fee Schedule

Finance Director Mark McRae expressed the Consolidated Fee Schedule was adopted on June 16, 2020. The Tentative Budget for 2021-22 includes a change to the Sewer Utility Fee and the Sanitation Fee requiring an update. Additional grammar and clarification changes were also made by staff. The Consolidated Fee Schedule went before the City Council on June 8, 2021 for discussion.

Councilwoman Petty reported the Parks and Recreation Committee would be reviewing the possibility of pickleball and basketball court rental fees. Councilman Winsor indicated there is no time limit on rentals and suggested the committee review the issue.

Councilman Soderquist moved to approve Resolution 21-36: Consolidated Fee Schedule. Councilwoman Alberts seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

### 8. Resolution 21-37: Posse Grounds Repair

Mayor Sjoblom related the 2020 windstorm damaged the fence and lawn area at the Posse Grounds. Insurance provided \$25,000 for repairs. \$5,738.50 for fencing and \$158.15 for road base was already spent. The remaining money is for fire pit, sprinkler, and sod repair. Public Works requested quotes from 3 companies: Ferrin Brothers, Groundworks, and Old School. Only Groundworks submitted a bid, for \$18,000 plus tax. Councilman Halverson clarified tax is only on materials and not labor. David expressed due to the water situation the sod installation may be delayed.

Councilman Soderquist moved to approve Resolution 21-37: Posse Grounds Repair to Groundworks for \$18,000 plus tax. Councilwoman Petty seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

### 9. Resolution 21-38: Proposed Property Tax Certified Tax Rate

Mayor Sjoblom explained each year Davis County looks at all properties in the city and determines their assessed value, then works with the state to determine the certified tax rate for the city. This year the city will be holding a Truth in Taxation hearing on August 17, 2021 regarding the proposed tax rate. The final Certified Tax Rate will subsequently be adopted on August 24, 2021. This item is to adopt a proposed rate that will be used for the Truth in Taxation hearing. The proposed property tax rate for 2021 is 0.001522 for an estimated revenue of \$932,646.

Councilman Winsor moved to approve Resolution 21-38: Proposed Property Tax Certified Tax Rate of 0.001522 for 2021. Councilman Halverson seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

### 10. Fraud Assessment Report

Finance Director Mark McRae averred South Weber City takes its financial and fiduciary responsibilities very seriously. Policies, procedures, and internal controls have been adopted and implemented to protect city funds. The yearly Fraud Risk Assessment is one indicator of how well the city is doing. The current level is "Low" which is better than the previous year. The Audit Committee set a goal to reduce the points by 20 in the current calendar year moving the rating to "Very Low". The results were presented to the City Council. Councilman Winsor thanked the city staff for their improvements. Mayor Sjoblom acknowledged her thanks as well.

Councilman Winsor moved to approve the fraud assessment report. Councilman Halverson seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

### 11. Garbage Can Purchase

Mayor Sjoblom stated South Weber City purchased differing types of residential curbside garbage cans from various providers in the past, trying to find the best price for ones that will withstand the typical wear and tear in the city. Public Works found Toter provided the can with the needed level of weight and durability, lid latches, and stack ability for storing large quantities. Toter is on the state contract and their quoted price for 624 cans is \$38,364.89.

Previously the City purchased quantities of 300 cans at a time which is just less than half a truckload. The purchase being presented to the Council today for approval is for a full truck load (624 cans) to receive the best price per can available. This purchase will come from the FY 2022 budget. No purchase was made during the FY 2021 budget due to sufficient inventory so that money will be carried over into the 2022 budget which will need to be adjusted prior to final adoption to include the cost of the full load. The budgeted amount is \$16,000 and the bid amount is \$38,364.89.

Councilman Halverson moved to approve the garbage can purchase to Toter for 624 cans at \$38,264.89. Councilman Winsor seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

### **DISCUSSION**

### 12. Auditor Contract

City Manager David Larson voiced Keddington and Christensen are the current auditors for the city and have been for the last five years. They were originally contracted by the City Council in 2016 with a four-year contract for \$10,000 per year. That contract expired in 2019 but was extended for one year to do the FY 2020 audit, which ultimately was billed at \$12,500 due to its complexity. The city has no reservations concerning the professional services provided by our current auditors. The City's auditors are chosen by the City Council and report directly to the City Council.

David revealed the Audit Committee met on June 9, 2021 and discussed options for this year's audit which are:

1. Contract with Keddington and Christensen for an additional 5 years according to their latest proposal at \$12,000 the first year plus a 3% increase each subsequent year.

2. Sign a one-year contract with Keddington and Christensen at the new rate of \$12,000 per year. Send out an RFP for auditing services in January 2022 in preparation for next year's audit.

3. Issue an RFP as soon as possible for this year's audit.

Councilman Soderquist confirmed the Audit Committee's recommendation is option 2. The current auditors are aware and agreeable with option 2. The City Council supported option 2. A contract will be prepared and come before the City Council for action in a later meeting.

### 13. Fireworks Ban:

City Manager David Larson summarized the current drought situation throughout the state of Utah. The city staff has presented the same fireworks map with minor changes for the last five years. City Attorney Jayme Blakesley read from State Code 15A-5-202.5 and identified four different categories relating to fireworks restrictions within a municipality. Chief Tolman confirmed the South Weber Fire Department uses the state guidelines for development of the map for the city. Councilwoman Alberts represented the Country Fair Days Committee would like further clarification concerning the professionally scheduled fireworks. Chief Tolman clarified professional fireworks are different in that the Fire Department is on hand. He felt comfortable moving forward with the Country Fair Days fireworks. David acknowledged there are other cities which have designated areas where individuals can gather to light fireworks; however, there is not an appropriate area in South Weber City. Chief Tolman reviewed the possible locations and how difficult it would be to find a place for parking, traffic control, policing, pedestrians, etc. Councilwoman Petty asked if the ban could be extended to include the Geneva gravel pit. Councilman Halverson favored banning aerial fireworks. Councilman Soderquist questioned how to enforce a ban. Chief Tolman replied that the Davis County Sheriff's Department (DCSD) would need to help with enforcement. Councilman Winsor suggested banning all fireworks across the entire city and requesting more patrol from DCSD. Councilwoman Alberts and Petty agreed.

Councilman Winsor moved to ban all fireworks within South Weber City limit boundaries for the 2021 season with exception for the fireworks at Country Fair Days. Councilwoman Alberts seconded. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

### REPORTS:

### 17. New Business:

Mayor Sjoblom acknowledged there are Council Members who can't attend the 13 July 2021 City Council Meeting. Council decided to move the meeting to 20 July 2021.

Mayor Sjoblom brought up the Country Fair Days Parade. Councilman Halverson was willing to provide a trailer with hay bales. Councilwoman Alberts requested music be broadcast. Councilman Winsor volunteered battery powered speakers.

Councilwoman Alberts related a resident's concern that the air conditioning in the Family Activity Center was not functioning. Davis School District maintains the environmental controls. Councilwoman Petty suggested looking into updating the agreement between the city and Davis School District. David will reach out to Curtis and report back to the City Council.

### South Weber City Council Meeting

Councilwoman Petty questioned the opening date for the Dog Park. David responded there are still some minor elements concerning public use being clarified. It will open as soon as possible.

### 18. Council & Staff:

**Mayor Sjoblom:** attended a Council of Governments (COG) meeting and reported the Utah Defense Alliance received a Ground Based Strategic Deterrent (GBSD) Contract Award in 2020 for a \$75 billion multi-decade program with Northrop Grumman Corporation as the prime contractor. The US Air Force estimates 125% additional community economic impacts above salaries. A combination of US Air Force and Northrop Grumman will generate 4,700 jobs above the 2,000 recently created. HAFB population is estimated to grow from 31,000 to 40,000+ by 2025. As a result, there is a shortage of housing for these new workers which could be one of the big reasons the state legislature is pushing for more moderate income and high-density housing.

**Councilman Halverson:** reviewed the Planning Commission meeting held on June 10, 2021. The final plat for Riverside Place Phase 4 was approved. He suggested Code Enforcement Officer Chris Tremea look into weed maintenance for this area. Geneva Rock was not in attendance and therefore the rezone request was tabled. Councilman Halverson suggested researching whether there was an agreement years ago between Geneva and the city. The Planning Commission recommended the City Council approve rezone requests for both South Weber Gateway and Stephens' Exit. Councilman Halverson encouraged the City Council listen to the audio of the Planning Commission meeting.

**Councilwoman Alberts:** expressed the Public Relations Committee was still in the process of working on the city website.

**Councilman Soderquist:** conveyed the US 89 construction project was delayed due to unavailability of concrete. He spoke with the manager of the US 89 project about the impact of traffic backing up on US 89. He met with the gravel pit representatives. He explained they are under the same water restrictions as the residents resulting in the dry berm along South Weber Drive. David informed everyone large water users may be required to water during daytime hours, so the water pressure is sufficient for residents. Councilman Soderquist further stated there will be additional dust as a consequence of water restrictions, but state monitoring will continue. Additionally, dust collection boxes will be installed around the city beginning in July to get a better understanding of the problem.

**Councilwoman Petty:** shared the Youth City Council went hiking. She advised that applications for next year's Youth Council will be on the city website very soon and encouraged residents to apply. The Parks Committee met with the South Weber Model Railroad Club. Meetings will continue with Hogan Construction to discuss Canyon Meadows Park.

**Councilman Winsor:** related Code Committee met to discuss Title 10 regarding water conservation for landscaping. They continue working on noise, dust, internal accessory dwelling units, etc.

**City Manager David Larson:** announced Trevor Cahoon is the new Community Resource Director and will begin in July. He thanked Planner Shari Phipps for all that she has done in her short tenure.

**Finance Director Mark McRae:** communicated the city applied for the American Rescue Plan Act (ARPA) fund and received a figure of \$927,395.00. He clarified the money has been named the Coronavirus Local Fiscal Recovery Fund (CLFRF). The city has until December 2024 to spend the money.

**ADJOURN:** Councilwoman Petty moved to adjourn the Council Meeting at 7:22 p.m. Councilman Soderquist seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

Mayor Sjoblom called the meeting to order and welcomed those in attendance and excused Councilman Halverson.

### 1.Ordinance 2021-09: Restricting Personal Fireworks

Mayor Sjoblom reported the City Council discussed the possibility of restricting fireworks during the June 22, 2021 City Council meeting and decided the safety issue outweighs the entertainment value. Ordinance 2021-09 will create a temporary restriction of personal fireworks while allowing the professional display for Country Fair Days in August.

Councilman Winsor asked Fired Chief Tolman if there have been any changes according to the state's perspective. Chief Tolman replied there have been no changes and discussed the extreme fire conditions in regard to the drought situation throughout the state.

Councilman Soderquist conveyed the ordinance talks about fireworks initially, but then Section 1 restricts four other potential fire concerns. He expressed the need for further clarification

concerning outside fires, outside smoking, sparking machinery, and sky lanterns. He questioned if individuals who smoke outside on their property will need to smoke inside and whether regulating spark generated equipment would hold up construction projects throughout the city. He was also concerned about who would be enforcing such regulations.

City Attorney Jayme Blakesley explained this is a legislative decision for the City Council. He remarked if the City Council wanted a less restrictive ordinance, then that was within their prerogative to amend the draft. He then explained the term "controlled use of any ignition source" comes directly from state statute. It does not define ignition source exhaustively but provides some examples. The ignitions sources listed in the ordinance were recommended by Chief Tolman as the types that may pose problems.

Chief Tolman described the extreme fire conditions this year. He reviewed the city adopted the Wildland Urban Interface (WUI) fire code approximately four years ago, which provides guidance. He expressed if the City Council felt strongly enough to take these actions, then all things listed in the state code that are a significant hazard should be included. He acknowledged the WUI fire code is followed every year by the city, regardless of extreme fire conditions.

Councilman Winsor was not comfortable telling people they cannot smoke on their property. Chief Tolman advised the Council needed to draw a line in the sand as to what they will and will not allow. Councilman Winsor argued fireworks having sparks that cannot be controlled does not compare to a person smoking. Chief Tolman commented the State Fire Marshal communicated if any city restricts more than what state code allows and the city chooses items from state code or the WUI rather than all inclusive ban, then lawsuits become a real possibility. Councilman Soderquist related the WUI lists exceptions for items creating sparks except for fireworks. He reviewed the unique safety hazards with the city being located in the mouth of a canyon where wind is prevalent and can escalate a fire quickly. He suggested using the language in the WUI which advises everyone to be cautious when within 30 ft. of dry brush. Councilwomen Alberts and Petty agreed.

Jayme suggested Section 1 to be amended as follows:

Section 1. <u>Prohibition on Personal Fireworks</u>. Pursuant to the provisions of the *Utah Code Ann*. 15A-5-202.5, and based on the findings as noted above, the use of fireworks is hereby prohibited in all areas of South Weber City. This restriction shall remain in effect until October 15, 2021, unless earlier terminated by action of the City Council. This prohibition shall not apply to permitted public fireworks displays authorized by the City and approved by the City's fire code official.

Mayor Sjoblom asked Jayme for his advice concerning whether this will open the city up for possible litigation. Jayme expressed litigation is a concern, but the state code does not prohibit a city-wide ban of fireworks. He can see how other attorneys might read it that way because it has a criterion by which you have to establish those areas where fireworks can be restricted. First, you need a determination from the city fire chief that the conditions in the city are high risk for fire which Chief Tolman has presented. He commented there is the criteria that was discussed in the last Council Meeting concerning mountainous, brush covered, forest covered, or dry grass covered areas within 200' of waterways, trails, canyons, washes, ravines, or similar areas, and the wildlife land urban interface area. The statute allows, if it is not feasible to draw a bright line, you can error a little bit beyond those areas if necessary. It was his understanding from the

Council last week that much of the city falls within those categories and it was only feasible to draw a bright line by restricting the use of fireworks within the city as a whole.

Councilman Soderquist added he was not sure individuals understand the WUI restrictions and questioned if that information should be included. Councilman Winsor suggested sending out a public service announcement with that information and keeping this ordinance specific to just fireworks.

Councilwoman Petty asked about sky lanterns. Chief Tolman cautioned sky lanterns are more dangerous than fireworks. After a brief explanation of what they are and the similar danger they present, the Council agreed they should be banned.

Councilman Soderquist moved to approve Ordinance 2021-09 Restricting Personal Fireworks as amended. Councilwoman Alberts seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

CLOSED SESSION held pursuant to the provision of UCA section 52-4-205 (1) (d)

2. Discuss the purchase, exchange, or lease of real property

Councilwoman Alberts moved to adjourn the Council Meeting at 6:22 p.m. and go into CLOSED SESSION held pursuant to the provision of UCA section 52-4-205 (1) (d) to discuss the purchase, exchange, or lease of real property. Councilman Winsor seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

18. Return to Open Meeting and Adjourn

Councilman Winsor moved to open the Council Meeting at 7:41 p.m. Councilwoman Petty seconded the motion. Mayor Sjoblom called for the vote. Council Members Alberts, Halverson, Petty, Soderquist, and Winsor voted aye. The motion carried.

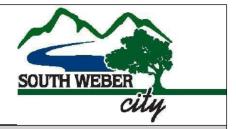

### Planning Commission Action

At the June 10, 2021, the Planning Commission voted 4-1 to approve the rezone, as requested. Commissioner Johnson voted against the motion but did not state his reasons why. The Commission was also in favor of the Council including a rescind clause, so that if the project does not proceed as presented, it will revert to the original zoning. As the project proceeds, they would like to see the project pay particular to the traffic impacts as it relates to Highmark Charter School.

The Commission was in favor of the split zoning and in favor of limiting the R-7 zoning to the portion of the property that will actually have residential on it, rather than the total project size.

### Executive Summary/General Plan Analysis

This parcel is located just west of Highmark Charter School. There have been ongoing discussions on the development possibilities of the property. Both the City and the developer felt that the appropriate step would be for the developer to bring forward a rezone application, accompanied by a concept plan, so that a formal action can be taken on the request.

It should be noted that the concept is not a final development plan, and that approval of a rezone does not equal approval of a development plan. Discussions on phasing, access and other things related to zoning and engineering will happen as part of the review of the preliminary and final plats. That isn't to suggest that they can't be discussed at all, but the details of those are finalized at development stages that come after the rezone, if the rezone is granted.

While the General Plan calls out that this property will be zoned commercial highway, it also calls out that the City should put a development plan/agreement in place. During the discussions before the General Plan was adopted, the Council determined that a residential component could be put into the development plan/agreement, subject to review and approval by the City.

The developer had discussions in City Council meetings regarding the residential densities that would be acceptable on the property. Council discussions indicated that the developer would only be granted density on the portion of the project that is being developed as residential- the developer would not be granted any residential density on the portion zoned commercial highway. The proposed 62 units fits within the density allowed on the R-7 portion of the property.

### **Staff Analysis**

As this is a legislative issue, the Council's role is to act on an ordinance that would rezone the property. The Council may approve or deny the request. The Council may also attach conditions or recommendations to its motion to the Council.

The rezone request is compliant with the General Plan's projected land use for the property, to the extent that it contains a commercial highway element and the developer has agreed to enter into a development agreement with the City. Additionally, as previously stated, the residential density proposed complies with the portion of the property proposed to be zoned residential. Because City code does not require a certain ratio of commercial to residential, staff cannot present an analysis of whether the ratio complies with any requirement.

### Planning Commission Action

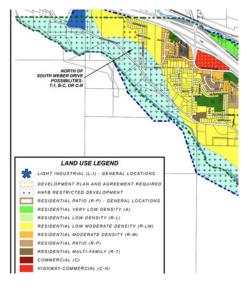
At the June 10, 2021 Planning Commission meeting, the Commission voted 5-0 to recommend that the Council approve the rezone request. They had no considerations, formal or otherwise, that they felt the Council should take into consideration.

### Executive Summary

This project was tabled at the May 13, 2021 Commission meeting. That was done in anticipation of the City Council taking up the land use matrix for deliberation. At the May 25, 2021 meeting, the Council adopted the land use matrix. My comments have not changed since the May 13th meeting, but are being included again.

This parcel is located on the corner of 475 East and 6600 South in South Weber City. The applicant, with consent of the developer, has applied to rezone the property from its present zone of Agricultural to Commercial Highway. They have not presented the City with a concept plan as to what they want to do with the project.

The City Council and Planning Commission have, in the past, requested that rezone applications come forward with a concept so that the City has some assurance of what types of projects are intended for properties.



### **General Plan Analysis**

The image on the left is from the Projected Land Use Map of the 2020 South Weber City General Plan. The Stephens' property is in red in the top corner of the image. As you can see from the image and from the key, the property is projected to be rezoned to Highway Commercial.

The crosshatch that is on the property does indicate that the City has the option to consider a master planned project on the property via a development plan/agreement. That would require additional information from the developer and is not being requested at this time. A development plan/agreement is not required to process a rezone, it is simply another option available.

The application, to the extent that it is requesting a rezone to Highway Commercial, complies with the General Plan.

### **Staff Analysis**

As this is a legislative issue, the Commission's role is to either approve or deny an ordinance that would rezone the property. Legislative actions allow the City to make additional requests beyond what is in the application.

The rezone request is compliant with the General Plan's projected land use for the property.

The applicant has not provided a concept plan, which the Commission and Council have requested accompany rezone applications. While a concept is not specifically required in a rezone application, having one allows the City to have some understanding of the developer's intent in pursuing the rezone.

If the Council chooses to deny the rezone, the developer does have the option of submitting a new application and going through the rezone process again.

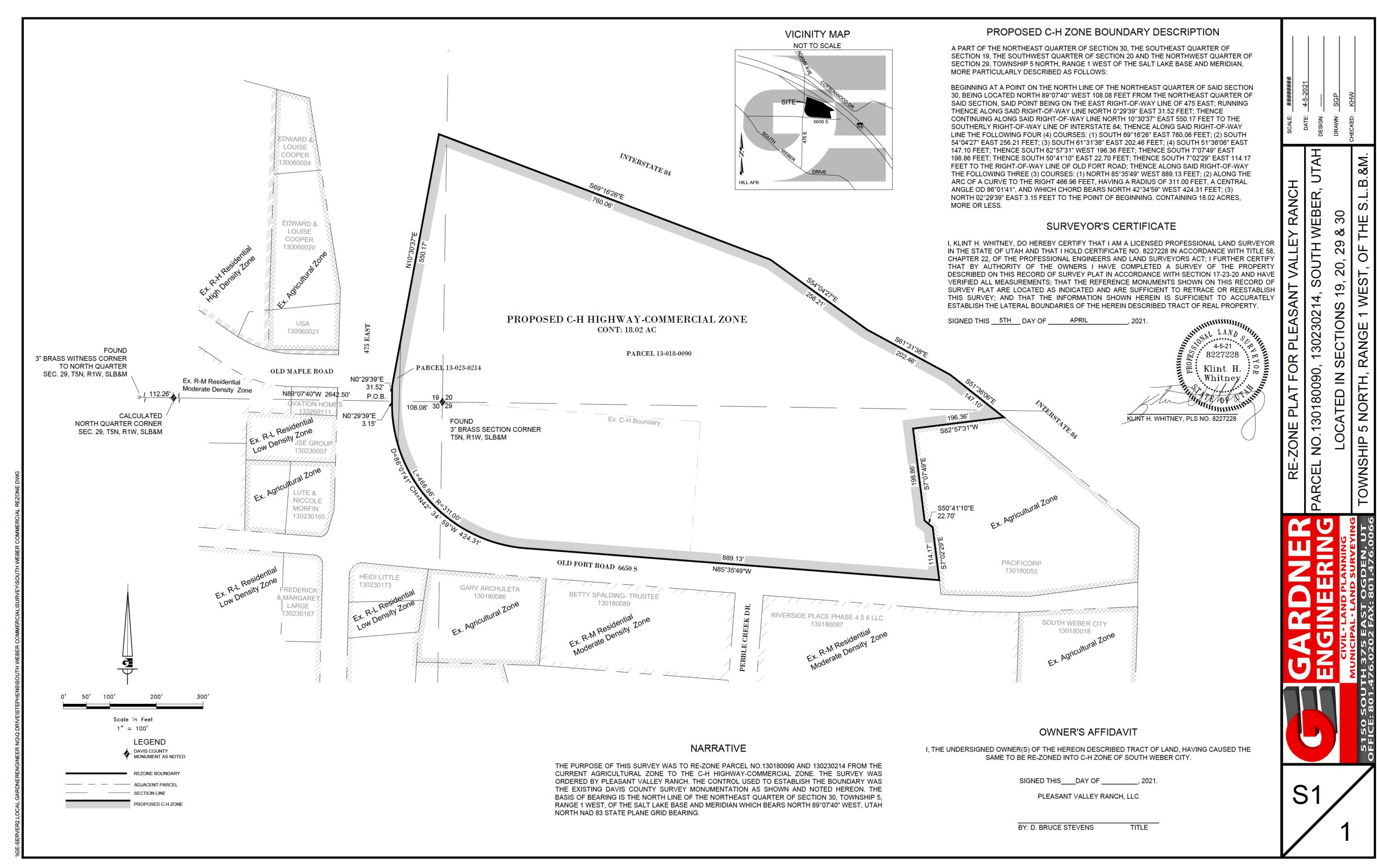

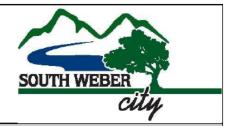

#### Planning Commission Action

At the June 10, 2021 Planning Commission meeting, the Commission voted 5-0 to recommend the final plat to the Council for approval. There were no conditions or suggestions made, beyond the minor changes that were indicated in staff review memos.

#### Executive Summary

This property is located at approximately 6700 South Pebble Creek Drive (575 E 6675 S). This is the fourth phase in the subdivision and builds off of previously completed phases. The project has been reviewed by staff for compliance with all relevant City zoning and engineering codes, standards and specifications, and is fully compliant with all relevant standards, with exception noted below.

The following items were identified by City Engineer Brandon Jones as needing addressed/corrected prior to the final plat being presented to the City Council for review. A copy of his review letter is included in the packet.

- The developer should provide a letter to the City from South Weber Irrigation Company stating that SWIC has reviewed the improvement plans and that those plans meet SWIC requirements.
- Add the Address Table to the plat so that it is clear which lots have which coordinates.

- Verify correct bearings along north boundary line / Old Fort Road.
- Verify that the improvements shown along Old Fort Road are shown in the correct location.

#### **General Plan Analysis**

The property was rezoned to R-M prior to the preliminary plat being approved, so there is no rezone or further general plan analysis to be done with this phase.

#### **Staff Analysis**

Administrative decisions such as this are not subject to public or personal opinion, but rather are subject to evaluation based on the plain language of City code.

When the preliminary plat was approved, it took into account minimum lot sizes, lot widths, setbacks and other zoning requirements. This final plat is in line with the approved preliminary plat.

The lot size standards, and how the plat meets or fails to meet each relevant standard, are below.

- A. Density: There shall be no more than 2.80 building lots per acre contained within the boundaries of each phase of every subdivision or planned unit development; except when previously completed phases of the same development have sufficiently low density so that the average is still 2.80 building lots per acre or less. (Ord. 15-05, 7-14-2015)
  - a. The density of this plat is 3.02 building lots per acre (12 units on 3.91 acres). Although this is outside of the 2.8 lots per acre, previously completed phases fall far enough below the 2.80 maximum that the density of all phases of Riverside still lies at or below 2.80 building lots per acre.
- B. Lot Area: All lots meet or exceed the required 9,000 sq ft minimum lot size.
- C. Lot Width: When factoring in all previous phases of the development, the average lot width meets the required 90' minimum.

In all material aspects related to zoning and engineering, it is staff's opinion that the plat is compliant. Minor engineering corrections have been noted under "Executive Summary".

Our office has completed a review of the Final Plat and Improvement Plans for the Riverside Place Phase 4 Subdivision, received May 24, 2021.

Roads were stubbed from these phases and the new Riverside Way is connecting these stubs. The lots on the north back on Old Fort Road, but do not have any access to Old Fort Road. **Background:** Keddington and Christensen are the current auditors for the City and have been for the last 5 years. They were originally contracted by the City Council in 2016 with a four-year contract for \$10,000 per year. That contract expired in 2019 but was extended for one year to do the FY 2020 audit, which ultimately was billed at \$12,500 due to its complexity. The City has no reservations concerning the professional services provided by our current auditors.

The City Council met on June 22, 2021, and discussed options for this year's audit. The council chose the option to:

Sign a one-year contract with Keddington and Christensen at the new rate of \$12,000 per year. Send out an RFP for auditing services in January 2022 in preparation for next year's audit.

The City's auditors are chosen by the City Council and report directly to the City Council. A contract has been prepared based on the June 22<sup>nd</sup> discussion and is brought forward tonight for approval.

Even our newest staff participate in the reconciliation and reporting services that we provide to these consulting entities. Also, our training and continuing education programs exceed the minimum requirements for auditors of governmental entities, and CPA licensure requirements.

The third benefit we mentioned was not charging for phone calls. This concept may seem simple and "common sense", however, we noticed that many of our clients were hesitant to contact their former auditors because they were always charged for every minute of every phone call. We believe that type of practice to be a disservice to our clients. We prefer to have open communication with our clients so that issues, concerns, or questions can be resolved throughout the year as they arise, instead of becoming potentially bigger issues after year end when reporting deadlines are looming.

#### **<u>C: PROPOSER'S APPROACH TO THE EXAMINATION</u>**

#### **Scope and Objective**

We will audit the basic financial statements of the City as of June 30, 2021. Our audits will be conducted in accordance with auditing standards generally accepted in the United States of America and the standards for financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States, and will include tests of the accounting records of the City and other procedures we consider necessary to enable us to express such an opinion.

We will provide a report (that does not include an opinion) on internal control related to the financial statements and compliance with laws, regulations, and the provisions of contracts or grant agreements, noncompliance with which could have a material effect on the financial statements as required by *Government Auditing Standards*.

We will also complete the audits in accordance with the Single Audit Act (if necessary) under the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (2 CFR 200). We will also perform audit procedures as outlined by the Utah State Auditor's Office State of Utah Compliance Audit Guide and issue the appropriate reports and opinions.

#### **<u>C: PROPOSER'S APPROACH TO THE EXAMINATION (Continued)</u>**

#### **Audit Procedures**

Our audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements; therefore, our audit will involve judgment about the number of transactions to be examined and the areas to be tested. We will plan and perform the audit to obtain reasonable rather than absolute assurance about whether the financial statements are free of material misstatement, whether from (1) errors, (2) fraudulent financial reporting, (3) misappropriation of assets, or (4) violations of laws or governmental regulations that are attributable to the entity or to acts by management or employees acting on behalf of the entity.

Our procedures will include tests of documentary evidence supporting the transactions recorded in the accounts, and may include tests of the physical existence of inventories, and direct confirmation of receivables and certain other assets and liabilities by correspondence with selected individuals, creditors, and financial institutions.

A successful audit provides the highest level of assurance on the reliability of the financial statements. Our audit approach also takes a businessperson's perspective to the examination of the financial statements. We pride ourselves on being available to our clients throughout the year so we can make helpful and profitable observations and suggestions to improve operating efficiencies and control structures.

#### Communications

#### E: FEES

Our fees for the proposed services for South Weber City will be \$12,000 for the fiscal year ended June 30, 2021. Included in our audit fee amount is all travel, per diem, and all other out-of-pocket expenses. Our fee amount is based on the current Finance Director, current key accounting personnel, the number of funds, the current auditing standards, the time requirements detailed in this proposal, and the accounting records being available to be audited prior to the audit field work each year.

#### Single Audit

An additional fee of \$750 will be charged for a Single Audit, if required, in any year. Estimated hours for a Single Audit varies based on the complexity of the grant and number of federal programs that need to be tested. On average, a Single Audit for one moderately complex grant requires 8-10 hours to plan, test, and prepare reports.

#### ACFR (Annual Comprehensive Financial Report)

If the City requires assistance in preparing a ACFR, an additional fee of \$4,000 will be charged for the first year. This fee anticipates the City will be responsible to obtain and accumulate all required information. For subsequent years, the fee would be \$1,000.

#### **Additional Services**

If the City requests additional services, the fee for those services will be negotiated at the time of service.

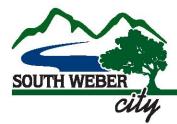
