

ORDINANCE 19-05

AN ORDINANCE VACATING A RIGHT-OF-WAY INTENDED FOR A STREET KNOWN AS SPAULDING DRIVE (600 EAST)

WHEREAS, Spaulding Drive (600 East) is an existing public street that connects to Petersen Parkway in the Canyon Meadows PUD that was platted, constructed, and stubbed for access to future development; and

WHEREAS, the City has determined that due to the development surrounding Spaulding Drive, sufficient access has been constructed or planned for and agreed to in accordance with current City development standards; and

WHEREAS, the City has reviewed and determined that there is no current or future need for the Spaulding Drive (600 East) right-of-way; and

WHEREAS, the City, through the Development Agreement for the Riverside Place Subdivision (approved as Resolution 18-24 by the City Council on April 17, 2018), has agreed to the vacation of Spaulding Drive (600 East) due to the connection of other public streets; and

WHEREAS, the proposed street vacation set forth herein has been reviewed by the City Council, and all appropriate public hearings have been held in accordance with Utah law to obtain public input regarding the proposed public interest in the section of the street.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF SOUTH WEBER CITY, STATE OF UTAH:

<u>Section 1. Findings:</u> The City Council finds that neither the public interest nor any person will be materially injured by the vacation and there is good cause for the vacation.

<u>Section 2. Street Vacation:</u> The following description of the Spaulding Drive (600 East) right-of-way, no longer serves a public purpose and is hereby vacated as a public right of way:

See Exhibit "A" and "B"

The east one-half of the right-of-way shall be conveyed to the owner of the adjacent property, <u>Christopher W. Perman & Amanda J. Perman as joint tenants</u>, said property being Lot 26 in the Canyon Meadows PUD (Parcel ID 13-220-0026).

The west one-half of the right-of-way shall be conveyed to the owner of the adjacent property, <u>Jason A. Koncher & Julie Koncher as joint tenants</u>, said property being Lot 27 in the Canyon Meadows PUD (Parcel ID 13-220-0027).

<u>Section 3. Reservation of Easements:</u> South Weber, for and on behalf of itself and all public utilities providing service within South Weber City, hereby reserves a permanent and

perpetual ten foot (10') wide public utility easement along the outside perimeter of the right of way being vacated, in addition to the existing five foot (5') wide public utility easements currently in place which are to remain, as shown in Exhibit "B."

<u>Section 4. Severability Clause:</u> If any part or provision of this Ordinance is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Ordinance and all provisions, clauses and words of this Ordinance shall be severable.

<u>Section 5. Effective Date:</u> This Ordinance shall become effective immediately upon passage and will be recorded with the Davis County Recorder.



Commissioner Osborne asked if there is any room to move the February 14th meeting to February 21st. The Planning Commission agreed to change the February 14th meeting to February 21st.

Commissioner Grubb moved to approve the consent agenda as amended. Commissioner Walton seconded the motion. Commissioners Grubb, Johnson, Pitts, Osborne, and Walton voted yes. Commissioner Johnson moved to open the public hearing for request by South Weber City to vacate Spaulding Drive at approximately 600 E Petersen Parkway as a public right of way to satisfy the conditions of the development agreement for Riverside Place Subdivision. Commissioner Pitts seconded the motion. Commissioners Grubb, Johnson, Pitts, Osborne, and Walton voted yes. The motion carried.

Public Hearing and Action on Street Vacation: Request by South Weber City to vacate Spaulding Drive at approximately 600 E Petersen Parkway as a public right of way to satisfy the conditions of the development agreement for Riverside Place Subdivision:

Commissioner Osborne asked if there were any public comments.

Eric Meacock, 617 Petersen Parkway, asked what is going on with this.

Brandon Jones, City Engineer, explained the procedure of vacating a street, which in this case, is Spaulding Drive.

Brandon stated the developer is not proposing to connect the subdivision to the abutting Spaulding Drive stubbed street. This will allow for an additional lot in the development. In the development agreement, the City agreed to allow the developer will not connect to Spaulding Drive. The City also agreed to initiate proceedings to formally vacate the right-of-way. The developer agreed to cap the existing underground utilities, remove the existing curb, gutter, sidewalk, and asphalt, and install curb, gutter, sidewalk, and asphalt across the southern boundary of the vacated right-of-way to completely remove the former intersection. This construction will be required along with the other improvements with the Riverside Place Phase 3 development.

Commissioner Walton moved to close the public hearing for request by South Weber City to vacate Spaulding Drive at approximately 600 E Petersen Parkway as a public right of way to satisfy the conditions of the development agreement for Riverside Place Subdivision. Commissioner Johnson seconded the motion. Commissioners Grubb, Johnson, Pitts, Osborne, and Walton voted yes. The motion carried.

****** PUBLIC HEARING CLOSED *********

Brandon discussed maintaining side yard easements. Commissioner Osborne said we need to find out exactly where the utilities are located. Brandon said before the vacation is recorded, a decision needs to be made on the utilities as to utility easement preservation.

Commissioner Johnson moved to approve the request by South Weber City to vacate Spaulding Drive at approximately 600 E Petersen Parkway as a public right of way to satisfy the conditions of the development agreement for Riverside Place Subdivision subject to removal or capping the utilities or identify the easement before it is turned over to the landowners. Commissioner Grubb seconded the motion. Commissioners Grubb, Johnson, Pitts, Osborne, and Walton voted yes. The motion carried,

Action on Final Plat and Improvement plans: Application for Harvest Park Subdivision, phase 1 at approximately 725 E 6640 S (29 lots) by applicant Bruce Nilson: Commissioner Osborne asked if there is any discussion from the Planning Commission. He noted Barry's letter of the 6 December 2018. He also noted the letter of 5 December 2018 from Jones & Associates. Commissioner Walton clarified that this is for phase 1 (29 lots).

HARVEST PARK PHASE 1 DEVELOPMENT REVIEW by Barry Burton 12.6.18 is as follows:


<u>Plat/Layout</u>: The layout of lots and roads is as approved with the revised preliminary plat. Lot widths and sizes also are as approved on the preliminary plat. The access road into the project through Riverside Place Subdivision is included on a separate road dedication plat. This plat will also need approval for this phase to have access from a dedicated public street. This section of roadway is included in the improvement drawings for Phase 1.

Development Agreement: There is an existing approved development agreement for Harvest Park that specifies, among other things, that the developer will dedicate the land for South Bench Drive and pay their proportionate share of the costs of construction of that road. The City will be constructing the road next year. It also specifies what the developer will do to improve the open space. Specifically, they will construct a detention basin that is also a public dog park with a 6' chain link fence and a 6' wide natural surface trail around the perimeter. (The Parks Committee met on Dec. 5th and recommended a design for the park that incorporates these items.)

The agreement also specifies that homes built on the lots on the west side of the property adjacent to Canyon Meadows will be restricted to a maximum height of 25'.

Recommendation: The Phase 1 Plat and the accompanying Road Dedication Plat along with the Development Agreement meet the requirements of Preliminary Approval and negotiations between the City and the developer. I recommend forwarding both plats to the City Council with a recommendation of approval.

Objective: Amend City Code 1.04.030 Official's Bond and Insurance

Background: Utah state code sets the requirements for Fidelity Bonds for Elected Officials and Municipal Treasurers. These requirements have changed over the last few years. Current code only requires cities of the First and Second Class to be bonded. The requirement for municipal Treasurers is defined in the Utah Money Management Act. For cities of our size, elected officials and the municipal treasurer may be covered by the city's blanket bond and/or criminal insurance policy. South Weber has criminal insurance through the Utah Local Government Trust. The criminal insurance provides proper protection for the city, and eliminates the additional cost of double coverage through individual fidelity bonds. This change to our code matches the current Utah State Code.

Summary: We are changing our code to match the current Utah State code concerning the bonding requirements for municipal elected officials and our treasurer.

ORDINANCE NO. 19-06

AN ORDINANCE OF THE SOUTH WEBER CITY COUNCIL AMENDING CITY CODE SECTION 1.04.030, OFFICIALS' BONDS AND INSURANCE

WHEREAS, the City Council desires to update and amend the city code to comply with State provisions regarding public officials' bonds and insurance, which allows insurance to be posted in lieu of bonds in some cases; and

WHEREAS, Utah Code Ann. 10-3-819 does not required bonds for elected officials in cities of the third class, of which South Weber City is one;

NOW, THEREFORE, BE IT ORDAINED by the City Council of South Weber City, State of Utah:

Section 1. Section Amended. Section 1.04.030 of the South Weber City Code is hereby amended to read:

1.04.030 Officials' Bonds

- A. Inasmuch as South Weber City is a city of the third class, no bond shall be required of the City's elected officials. Other officers of the City identified in this section shall furnish a personal bond with good and sufficient sureties or corporate surety bond payable to the City in such penal sum as established in this section, conditioned for the faithful performance of the duties of their offices and the payment of all money received by such officers according to law and the ordinances of the City, or such officers may be included within public employee blanket bonds at such amounts as stated in this section.
- B. The premium charged by a corporate surety for any bond required by the City or for crime or theft insurance shall be paid by the City.
- C. If bonds are posted, they shall be filed with the City Recorder, except the bond of the City Recorder shall be filed with the City Treasurer.
- D. Officials' bonds or insurance shall be provided in the following amounts:
 - 1. City Treasurer: 5% of the City's budgeted gross revenue for the previous year but not less than \$300,000; and
 - 2. City Recorder: \$2500.
- E. The Treasurer's bond may be substituted with crime or theft insurance in the amount specified by Rule 4 of the Utah Money Management Council and Utah Code Ann. 51-7-15 of the State Money Management Act.
- F. Pursuant to Utah Code Ann. 10-3-821, the City Treasurer's bond shall be superseded by any rule, regulation, or directive of the State Money Management Council.

Section 2. Severability Clause: If any part or provision of this Ordinance is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Ordinance and all provisions, clauses and words of this Ordinance shall be severable.

AN ORDINANCE OF THE SOUTH WEBER CITY COUNCIL AMENDING CITY CODE SECTION 1.04.030, OFFICIALS' BONDS AND INSURANCE

WHEREAS, the City Council desires to update and amend the city code to comply with State provisions regarding public officials' bonds and insurance, which allows insurance to be posted in lieu of bonds in some cases; and

WHEREAS, Utah Code Ann. 10-3-819 does not required bonds for elected officials in cities of the third class, of which South Weber City is one;

NOW, THEREFORE, BE IT ORDAINED by the City Council of South Weber City, State of Utah:

Section 1. Section Amended. Section 1.04.030 of the South Weber City Code is hereby amended to read:

1.04.030 Officials' Bonds

- A. Inasmuch as South Weber City is a city of the third class, no bond shall be required of the City's elected officials. Required: The elected officers of the City before taking office shall execute a bond with good and sufficient sureties, payable to the City in such amounts as are provided in Utah Code Ann. Section 10 3 801 et seq. of the Utah Code Annotated, conditioned for the faithful performance of the duties of the respective officers and the payment of all money received by such officer according to law and the ordinances of the City. All oOther officers of the City identified in this section shall may, by resolution or ordinance, be required to furnish a personal bond with good and sufficient sureties or corporate surety bond payable to the City in such penal sum as the resolution or ordinance may establishestablished in this section, conditioned for the faithful performance of the duties of their offices and the payment of all money received by such officers according to law and the ordinances of the City, or such officers may be included within public employee blanket bonds at such amounts as may be determined by the City Councilstated in this section.
- B. Premium Paid by City: The premium charged by a corporate surety for any bond required by the City or for crime or theft insurance shall be paid by the City.
- C. Additional Bonds: The City Council may at any time require further and additional bonds of any or all officers elected or appointed. AllIf bonds are posted, they given by the officers, except as otherwise provided by law, shall be filed with the City Recorder, except that the bond of the City Recorder shall be filed with the City Treasurer.
- D. OBond Amounts: Officials' bonds or insurance shall each be provided in the following amounts:
 - Mayor and Council: \$2500City Treasurer: 5% of the City's budgeted gross revenue for the previous year but not less than \$300,000; and
 - 2. City Recorder: \$2500_
- D.E. The Treasurer's bond may be substituted with crime or theft insurance in the amount specified by Rule 4 of the Utah Money Management Council and Utah Code Ann. 51-7-15 of





DRAFT Future Public Works Facility Process Plan

Plan Elements:

- Define the Problem
- Determine the Objective
- Identify Alternatives
- Analyze Tradeoffs
- Pre-Construction Steps & Timeline
- Community Involvement

Define the Problem:

The current Public Works Facility is deficient in many ways and has triggered a conversation about what is the best way to facilitate the Publics Works/Parks service to the community moving forward.

Determine the Objective:

A City Public Works/Parks department provides many of the essential services that define a city: water, sewer, storm drain, snow plowing, streets, etc. A facility that provides adequate space for both staff and equipment, as well as for storage and training is critical to the quality delivery of these services.

The current facility housing the City employees that provide these services has been used for many years and city growth has made it where it is physically inadequate in office space, storage space, equipment space, and training space. Even more than city growth, the building itself is old and in disrepair.

Two main options appear, while alternatives within these larger alternatives should be explored. The main options are to:

- Upgrade/Renovate the existing facility
- Build a new facility

An initial look into these options by staff has all but eliminated the option of renovating the existing facility, in part because of the cost of renovation and the remaining issues of the site and location even if the building itself was structurally sound.

Identify Alternatives:

Having determined that building a new facility would better serve the communities needs long term, the next step in this decision-making process would involve identifying the potential property within the City that could provide the necessary space to build a suitable facility.

Analyze Tradeoffs:

Selection criteria will need to be determined and used to compare alternatives, including site analysis (e.g. size of lot, access to major roads, isolation from residential areas, efficient use of ground, topography, access to existing utilities, potential hazards, location, and cost to purchase) and design/construction process (e.g. design-build, construction manager/general contractor).

Pre-Construction Steps & Timeline:

We are in the initial stages of a potential multi-year process. Staff anticipates the following tasks (not necessarily in this exact order) based on where we are today in constructing a new facility:

- Determine financing options
- Determine potential sites
- Purchase property
- Hire an architect and general contractor
- Complete program planning, including researching other cities' facilities
- Perform environmental and other studies needed prior to construction

Work on the first steps could commence immediately (i.e. determine financing options and potential sites). The results of those efforts would be a major factor in determining how quickly the City could move to hiring an architect and designing a facility.

Community Involvement:

So far, the Council and staff have simply identified a need. We are trying to create a plan to address that need. Any potential solutions would have an impact on the residents in terms of service level and cost.

It is important for the community to be involved early and throughout the process. What that involvement looks like needs to be discussed. It is important to understand what information the City needs to present to the community and what information the City needs from the community before any decision is made on outreach methods.

Some cities have gone as far as designed a building and presented that to the community as the first outreach, while other cities have involved the community at earlier stages in determining preferred solutions prior to designing any facility. We need to determine what is right for this particular need and our community.

Potential community outreach methods for consideration include:

- Tours of the current facility
- Social media informational posts
- Newspapers, news agencies
- Public Open Houses
- City-wide surveys
- Vote of the people (depending on financing option)
