September 17 / 1942 hrs / Suspicious/ Psych Problem

Received a call about a female walking door to door asking for money and a ride. While in the area looking, the female walked into another house and sat on the couch with the homeowner. The homeowner was able to contact family, who came over and the female left the residence and was located running toward 675 E. The female was identified and was pink sheeted due to schizophrenic behavior and which she has a significant history of.

September 18 / 2228 hrs / Suspicious-Drug offense

A Layton Fire Captain called his dispatch via radio to report a naked male in the neighborhood knocking on doors asking for help and telling people he was going to die. The male reportedly became aggressive prior to our arrival. Deputies arrived and were advised the male was unknown to any residents and had been hiding by a fence at a residence. The deputies found the front door of the residence open, items knocked on the floor and raised voices coming from the basement. They entered and found the male still naked and repeating "I'm going to die". He was Identified and transported to Ogden Regional for a Pink Sheet medical evaluation. While in the residence the odor of marijuana was observed along with several items of Controlled substances. A search warrant was gained. A large quantity of Marijuana, Dabs, paraphernalia and \$8500.00 in cash were seized.

September 22 / 0636 hours / Vehicle Burgs

Several vehicle burglaries in the Kay Lane area of SW. All vehicles appear to have been unlocked with property having been gone through. One of the victims had her purse taken with several credit cards. Those cards were used at a Maverik in Layton and a Smiths in Salt Lake City. The assigned deputy is conducting follow up on that case.

September 23 / 0346 Hrs / Evade

Deputy Jefferies attempted to stop a Black Sedan that failed to yield on south weber Drive. The vehicle entered South Bound 89 and Deputy Jefferies notified dispatch the vehicle was evading and he stopped pursuing. Several agencies including Layton and Clearfield observed the vehicle as it continued west and south through their cities. Layton was able to identify the vehicle as a 2000's model Balck Audi A4 with front end passenger side damage.

September 25 / 1616 hours / Domestic

Deputies responded to a domestic assault at the above residence. During an argument a male punched his son in law in the face, causing him to fall down the stairs. This occurred in front of the victim's 3 year old child. The suspect was booked into the jail for DV assault in the presence of a child.

September 23 / 1743 hours / Recovered Stolen Vehicle

A citizen called in to report a vehicle burglary at the above location. It was reported that two males were seen going through and taking items from a white Mercedes SUV (UT 9F9ZV) and then got into a silver Ford F150 (early 2000's model with a roof rack) and fled the area heading towards I-84. The males were described to be in their 30's to 40's with tattoos. One was wearing a "Miami Jersey". Upon arrival, it was found that the Mercedes SUV was listed NCIC as a stolen vehicle out of Cottonwood Heights, and did not belong in the area. Several items of evidentiary value were noted inside. Crime lab processed the vehicle and further follow up is pending with detectives.

October 3 / 1449 hrs / Suicide Threats

A female at a residence grabbed knives from the kitchen and attempted to cut her wrists. Her husband was able to take multiple knives from her. This is a recent onset of psych problems with her according to her husband. He has been frustrated with the resources for mental health help. The female was transported for a mental health evaluation. Deputies stayed on scene and gave resources for mental health to the husband

October 10 / 0026 hrs / Theft

It was reported to our shift from Dep Reid that several thefts of halloween decor had occurred in South Weber earlier in the day. One in particular that had been caught by someone on their home security. This provided a description of a female suspect and the vehicle she was in. We were called to the same area where homeowners had been awakened by their ring doorbell and saw that a female was taking their halloween decoration from their yard. Several homeowners boxed the suspect in her vehicle and called 911. The suspect was identified and matched the description from Dep Reid earlier theft. She admitted to being in the same area earlier and that she had traded something for the items taken. Charges were filed for the theft of the items that were taken and restitution requested. Some of the decorations were found the next day and returned to the owners

November 15 / 2006 hrs / Traffic Stop-Evade

A Deputy initiated a traffic stop on a vehicle leaving the Maverick in South Weber. The vehicle initially yielded and the driver was identified. During the traffic stop a K9 Deputy responded and had K9 Rino perform a sniff of the vehicle. While performing this the driver aggressively turned the wheel and accelerated. He nearly hit a Deputy and K9 Rino in his flight from the scene. Deputies initiated a pursuit on the vehicle. The watch commander requested the pursuit terminate as the driver was performing erratically. The pursuit was picked up by UHP after they had found the vehicle and the vehicle was successfully spiked. It then continued until it ran off the road at 500 South Legacy Parkway. Deputies continued to the scene and took the driver into custody. He had been seen throwing items out of the vehicle which were later collected and identified as large bags of marijuana. Methamphetamine paraphernalia was found inside the vehicle.

November 20 / 1124 hours / Child Abuse

A mother retrieved her 6 year old son from the father at the south weber residence. The mother noticed bruising on the child's cheek and chin. The child informed her that the father had grabbed his face and thrown him to the ground to discipline him for hitting his sibling. The child is with the mother for the time being. DCFS and Detectives interviewed both the child and the father. A search warrant was served at the residence and the suspect arrested for child abuse

November 25 / 1551 hours / DV Assault

Deputies responded to the report of an altercation called in from a neighbor who reported hearing yelling and slamming sounds within the home. Upon the arrival of Deputies, the same sounds could be heard and contact was made with the parties inside. It was determined that a male resident had been the primary aggressor and assaulted, choked, spit on and prevented the victim from calling 911 for help. The suspect was booked into jail for Assault (DV), Propelling a bodily substance (DV) and interrupting a communication device (DV). A jail release agreement is in place although the suspect will likely be held due to a probation violation (previous aggravated assault).

December 8 / 2322 hrs / Drug Offense

While patrolling the area for a suspicious vehicle called in as possibly stealing packages, a deputy made contact with a vehicle parked on 1900 E. Upon contact she observed an obvious odor of Marijuana. The occupants were all found to have drug paraphernalia and substance consistent with heroin use.

December 27 / 0057 hours / Traffic Stop

While conducting a routine traffic stop, Deputy Ryerson located a fugitive with an extraditable warrant out of Idaho as well as drugs and paraphernalia. The individual was booked into our jail to be held for the originating agency in Idaho.

January 5 / 1015 hrs / Identity Fraud

Victim had \$3000 fraudulently transferred from her account through VENMO after providing all of her account information & password over snapchat to someone who had hacked a friend's account. The investigation led to contact with the owner of the snapchat account that was hacked, and then to another victim who resides in Layton. Detective Lt. Valencia was consulted on this case.

January 7 / 1021 hrs / South Weber Fire Station / Theft

SW Fire had several equipment items stolen from their apparatus bay/garage. These items were reported to have been sold at a metal scrap yard in the Riverdale/Ogden area. The items were located and found to have the SW fire identifiers stamped on them. The return of the property to SW Fire is being facilitated. The scrap yard has security camera video of the suspect and vehicle that are going to be collected.

January 7 / 0740 hrs / Suspicious-Welfare Check

A male was contacted as a suspicious person sleeping on the ground of the church property at 1400 E. SW Drive. He was found to be okay, refused help, and without violation. He was left alone. Later, and throughout the day we received numerous calls on him wandering the entire city being suspicious and behaving unusual. Repeat contact was made. Mr. Dao did not want to talk to Deputies and did not identify himself. He was later observed climbing over a fence into the landfill property with no trespassing sign clearly visible. He was taken into custody and began making statements that he wanted to die. He also stated he was hit by a car earlier and presented with an injured leg. He was ultimately pink sheeted and transported for care at McKay Dee ER. It was discovered that Mr. Dao is homeless, and his vehicle was impounded in Riverdale, leaving him to arrange his own transportation from the area.

January 10 / 1913 hours / Family Disturbance

Shortly after day shift had dealt with a prior report of a fight between two brothers, we were again dispatched to the residence as one brother had returned home and the fight had continued. It was reported that one of them had brandished a gun and threatened to shoot and kill the other. A search warrant was obtained and the house was searched with no gun found, although meth, marijuana and paraphernalia were found. Charges were referred to the court regarding the illegal items and alleged assault. One of the males left the house for the night to stay at a motel. Further follow up will be conducted with the health department due to hazardous conditions in the home (raw sewage in the basement).

January 14 / 2238 hours / TS w/arrest

Deputy Ryerson initiated a traffic stop which resulted in an arrest for possession of CS/paraphernalia, possession of burg tools, and possession of a dangerous weapon by a restricted person. Arrestee was booked. Passenger in the vehicle was released on charges of unlawful possession of a financial transaction card.

Sheriff's Office Information

Davis County conducted drive-thru voting at the Legacy Event Center in Farmington on November 2nd and 3rd. Voters were able to arrive, fill out a ballot in their vehicle, and drive through to turn it in. This was a very successful event that ran very smoothly.
