RE: **SR-60 DRAINAGE AT SKYHAVE COVE PROJECT**

Date: September 12, 2018

Today, on September 12, 2018 at 2:00 pm., bids were opened for the SR-60 DRAINAGE AT SKYHAVEN COVE PROJECT. Five bids were received. The results of the bidding are shown on the enclosed Bid Tabulation. We have checked the bids and found no errors.

We have reviewed all bids and recommend that the Council award the project contract to **MARSH CONSTRUCTION**, based upon their experience in doing similar work, and their low bid of **\$101,640.00**. The project completion date is November 9, 2018. It should also be noted that the City Council recently approved an agreement with UDOT for this project that would reimburse the City for actual costs up to, but not to exceed \$110,000.

If the Council agrees with this recommendation, please pass a motion accepting the bid and awarding the project contract to MARSH CONSTRUCTION with their bid of \$101,640.00. We will provide the Contract Agreement and Notice of Award to sign. We will also provide these documents to the contractor for their signature. In addition to the signed Notice of Award and Contract Agreement, the contractor is also responsible to submit the following within 10 days:


1. Performance Bond

When these documents have been received, we will schedule a Preconstruction Conference. At this conference we will issue a Notice to Proceed and discuss the construction details with the contractor prior to beginning the work.
