Mayor's Message

Dear South Weber Residents,

The Wasatch Integrated Waste (or the Davis County Landfill) Board has approved a \$2/ month increase to their rate to go toward a new sorting facility in conjunction with construction of a transfer station at the landfill. As a result, your monthly garbage disposal bill will increase by \$2, from \$5.20 /month to \$7.20/ month beginning July 1. Construction on the new sorting facility will begin Spring of 2019 and will be operational in the fourth quarter of 2019. This facility will allow over 25% of all collected waste to be reused through recyclables, anaerobic digestion, and engineered fuel. It

will also protect the local landfill for another 35 years, keeping garbage disposal prices much lower for our residents over time. This new process will reduce odor to the landfill and help alleviate traffic issues at the plant.

South Weber City has organized an Economic Development Committee to assist the City in planning for future commercial development. This committee will work to determine what types of businesses we want in our City and where they should be located. It will also look at ways to make our City more friendly and inviting to those desired businesses. South Weber has very limited commercial zones, so we want to make sure we encourage the right businesses for our City. We realize there are a number of interested and well-informed business owners and leaders in our community and would welcome any insights and recommendations from the same. Please contact our City Manager, David Larson at 801-479-3177 or email him at dlarson@southwebercity.com. We also have a survey on the City Website that you can fill out. It consists of two question: 1. What type of businesses would you like to see in South Weber? And 2. Would you be open to the idea of a state liquor store in the City? Please don't panic. We have not even looked into the feasibility of putting a liquor store in South Weber. The only reason we are entertaining the thought is that it would be a substantial source of revenue for the City. Before we even consider the idea, we want to see how our residents feel about the possibility. If you have strong feelings either way, please take a couple of minutes to fill out the survey. The 2018 Water Season was less than normal and the summer was hot and dry. We have had some snow this year, but the watershed snowpack is basically at average (100-105%). Starting with low reservoirs, we need a good year to have them fill. It's still unknown if we'll completely fill them this year. With that said, this year we continue to encourage efficient use of the water and conserve where possible. Please adjust your watering based on the weather. Please strive to only water your yard based on its 'need'. The State website—

(http://www.conservewater.utah.gov/) states "the typical Utah household will use twice as much water outside as necessary." We encourage all users to reference the State website for their weekly watering guide.

We require meters on all new secondary water services and have begun to retrofit existing services with meters. We are sending water use reports to those with meters in an effort to better educate the end user and better manage our limited water resources. Please contact us (meters@davisweber.org) and provide an email address so the report can be sent to you monthly.

Thank you in advance for your water conservation efforts this upcoming water season. We want to continue the state ethic of efficiently using water in a wise manner. Check our website, www.davisweber.org, for further updates or restrictions. Remember to ensure your system is secure and ready for service by April 1st prior to us pressurizing the system. Often there is no need to water until May.
