#### Landfill Odor Reduction Update

Wasatch Integrated Waste (WIW) has been implementing several techniques to help reduce odor from the landfill. Last year, WIW put a berm around the north perimeter of the landfill to obscure view and alleviate odor as well as 3 new gas pipes in active areas for more gas collection, as some odor is caused by the gas from waste that erodes into the soil. The berm was unsuccessful and inadvertently caused drainage problems that slightly increased the odor instead of helping.

WIW will also be closing their burn plant, creating higher concentrations of organic materials in the landfill to help decompose materials and reduce odor as well as testing a new technique of applying liquid soil sealant and stabilizer to 60-70% of the active fill. If this approach works, within 1 month the odor should be mitigated. The first test application was applied last month. The final cover, to be placed on the north perimeter, should begin springtime of 2019. The transfer station will be ready for use in 2 years; residential organic materials will be extracted and transported to a different location causing less odor. The landfill is projected to close in 2039.

### UTA Summer Youth Pass (Rider's License)

The Youth Summer Rider's License provides unlimited rides on UTA from June through August for only \$75 (if purchased before June 15, 2017, otherwise this pass will be \$99 after this date). This License is only available for those between 6-18 years of age. Tickets go on sale May 1, 2017 and provide unlimited rides on UTA's FrontRunner, Trax, Busses & Streetcars.

## **Davis County Sheriff's Office**

A common crime trend with the warming weather is an increase in vehicle burglaries, criminal mischief, and thefts. ## Burn Guidelines

The city, county, and state laws regulating open burning in Davis County are limited to agricultural burning or recreational fires. The laws are defined below:

To qualify for agricultural open burning you MUST have 2 acres of farmland used for crop growth or a fruit orchard with 25 or more fruit trees. Agricultural open burning is limited to organic items, which are incidental and essential to the agricultural operation. NO TRASH OR YARD WASTE. Examples of items which may be burned are: Fence lines on cultivated property, stubble fields, ditch banks, weeds when clearing land to be planted, and trimmings from fruit trees when in conjunction with an orchard. State law requires that farmers who are going to burn such items notify the nearest fire department prior to burning. The SWC Fire Department requires that you notify us at 801.540.7094 and provide the start and end times of the burn, an address where the burning will occur, the name and phone number of the responsible party for the burn and the materials that you will be burning. Agricultural burns will be limited to daylight hours on days that the Clean Air Index allows.

All agricultural fires must be kept a minimum of 50-feet from structures. The responsible party must have a water supply or other means to control any fire. Any fire must be constantly attended until completely out.

The following types of recreational fires are permissible without a permit: 1) In devices for primary purpose of preparing food such as outdoor grills and fireplaces. 2) Campfires and fires used solely for recreational purposes where such fires are under control of a responsible person 18 years or older; 3) In indoor fireplaces and residential solid fuel burning devices.

Recreational fires shall not be conducted within 25 feet of a structure and must be constantly attended until the fire is extinguished. A water supply or fire extinguisher must be on hand. Fire must not be larger than 3ft in diameter and burning of any material other than firewood, charcoal briquettes, propane or L.P. gas is prohibited. SWC Department reserves the right to order a fire to be extinguished at any time.
