PROPERTY TAX RELIEF

Utah law allows Utah residents five types of property tax relief:

- Circuit Breaker (household income less the \$31,845)
- Veterans with a Disability Exemption.
- Active or Reserve Duty Armed Forces Exemption (see Utah §§59-2-1104 & 1105)
- Blind Exemption
- Indigent Abatement/Deferral

Specific information and application forms are available in the office of each county. Call the Davis county auditor's office, (801) 451-3250 or treasurer's office, (801) 451-3243 for clarification, deadlines and to answer questions. Code Enforcement

Having trees, weeds, bushes, or other debris overlap a sidewalk can be very dangerous for those that like to exercise using the safety of the sidewalks. However, when there is not enough passage along the sidewalk it forces pedestrians into the roadway, whom do not mix well with vehicles. Therefore, immediately after the distribution of this newsletter, warnings and/or citations will be issued for obstructed sidewalks both horizontally and vertically. Also, please do not allow landscapers to place boulders, rocks, or dirt over the sidewalk or on any portion of the roadway; you, as the homeowner, will be responsible for any damage to the roadways or sidewalks caused by landscapers.

7.01.030 Obstructions in Streets

It shall be unlawful for any person owning, occupying or having control of any premises to place or permit to be placed upon or in the sidewalk, parking area, gutter or on the half of the street next to such premises:

Refuse: Any broken ware, glass, filth, rubbish, sweepings, refuse matter, ice, snow, water, garbage, ashes, tin cans or other like substances.

Building Materials: Any wagons, lumber, wood boxes, fencing, building material, dead trees, tree stumps, merchandise or other thing which shall obstruct such public street, gutter, parking area or sidewalk, or any part thereof, or the passage over and upon the same, or any part thereof, except as expressly authorized by ordinance, without the permission of the City Council first had and obtained.

Permanent or Temporary Structures: Any permanent or temporary structure, mechanism, device, vehicle or other thing of any kind or character, except trees planted pursuant to the provisions of applicable ordinances.

<u>Height Limitations:</u> All sidewalks shall be kept clear and unobstructed to a height of seven feet (7'). No vegetation shall be allowed to extend into the street past the curb face or the edge of the pavement where there is no curb to a height less than fourteen feet (14').
