South Weber City will be having a municipal general election on November 7, 2017 for the following offices:

- Mayoral position (4-year term)
- 2 At-Large City Council Positions (4-year term)

This election will be conducted via mail. All registered voters should have been mailed a ballot at least 21 days before the General Election Day.

You can turn this ballot in by mail, in a drop box at City Hall, or at the Family Activity Center on Election Day from 7am-8pm.

Code Enforcement Notes

As the winter season approaches, please be mindful of keeping sidewalks by your property clear of snow. The failure to remove snow on sidewalks and shoulders causes frequent slips and falls for pedestrians.

For our guidelines on snow removal, please see 7.01.020 of our City Code which reads as follows:

A. Failure to Remove Unlawful: It shall be unlawful for the owner, occupant, lessor or agent of any property, abutting on a paved sidewalk, to fail to remove or have removed from such paved sidewalk, all hail, snow or sleet thereon within a reasonable time after such snow, hail or sleet has fallen. In the case of a storm between the hours of five o'clock (5:00) P.M. and six o'clock (6:00) A.M., such sidewalks shall be cleaned before nine o'clock (9:00) A.M. of the same day.

B. Depositing in Gutter Unlawful: It shall be unlawful for any person removing snow from the sidewalk or driveway or other areas, to deposit or blow snow, dirt, leaves or any other material in the street, nor should any of these materials be deposited in the gutter so as to clog or prevent the free flow of water therein. If you feel that there is a risk or hazard in our community in any regard, please notify the code enforcement officer so that we can address the issue quickly. It is the property owners' responsibility to clear all areas immediately surrounding their properties. If possible, please help your neighbors that may be less fortunate or not able to complete the task of removing the snow from their property.



A Message from Davis County Sheriff's Office



Greetings South Weber City Residents. The holiday season is fast approaching and with it brings a good time to remind everyone about Identity Theft and Fraud. Once identity thieves have your personal information, they can drain your bank accounts, run up charges on your credit cards, open new utility accounts, use your medical insurance, and even file for your tax refund. Beware of phone solicitors and never provide personal or financial information without first verifying who it is. A quick web search and use of an alternate source to obtain the contact information, followed with you calling back the business to verify the legitimacy of it, can prevent you from being a victim of fraud or identity theft. Second, monitor your credit reports. Each credit reporting agency allows one free credit report a year. Rather than obtaining all three credit reports at once, spread them out over the year for continuous monitoring of your credit for any suspicious accounts. Another common fraud crime occurs when selling items to a private party. Thieves will send a check to purchase the item in a larger amount than the actual sale amount asking that a money order of the difference be sent back to them. Never send a money order without first verifying the buyer's legitimacy. Most often, the check received is fraudulent and you will lose the money that was paid for the money order.

Before you become a victim of Identity Theft or Fraud, visit the website www.identitytheft.gov which is full of information of how to protect yourself, what to do if you are a victim, and where to report crimes of Identity Theft and Fraud. By reporting the crime to identitytheft.gov, you are reporting it directly to the Federal Trade Commission. The next step is to report the crime to the Davis County Sheriff's Office. Often, these crimes are committed interstate or even international, which makes them very difficult for local law enforcement to investigate and hold those responsible accountable, so educating ourselves and preventing these crimes all together is the best solution.
